The terms of confidentiality of personal data

The present privacy terms and conditions apply to all the information that the site may obtain about you while you use the resource. Your use of the site constitutes acceptance of these terms and conditions of personal data confidentiality and processing. If you do not agree to the privacy policy, please don't use the service. The present privacy policy applies to this site only. The site administration neither controls nor carries the responsibility for third parties sites available on this site to which you may click the links on. The site administration does not verify the validity of the personal data provided by you. You warrant that the personal data provided is valid and accurate, and you agree to notify the site administration of any changes to such data. Any damages incurred by you, by the site administration or by third parties resulting from receiving erroneous, inaccurate or incomplete data in forms of personal data capture will be your exclusive responsibility.

Your personal data may be processed by filling in the forms for obtaining personal data and includes as follows:

- a. surname, name, patronymic;
- b. contact phone number;
- c. e-mail address;
- d. the name of the company which you represent;
- e. current occupation;
- f. residence and/or work place.

The site provides statistical data:

- a. IP-address;
- b. information from cookies;
- c. information about your browser (or any other program that accesses the display advertising);
- d. access time;
- e. the URL of the page of the ad unit;
- f. referrer (the address of the previous page).

Disabling cookies may result in the inability to access certain portions of the site.

Any personal information not mentioned above is to be kept and secret. The site administration shall have the right to transfer personal information to third parties, in particular, express services, postal organizations, telecommunication operators. If you provide personal data of third parties, you are responsible for informing third parties on the use of this data as well as for obtaining consent.

The site administration can use the personal data in order to:

The administration of the site together with the user shall take all necessary measures to prevent adverse effects caused by the loss or disclosure of the user's personal data.
